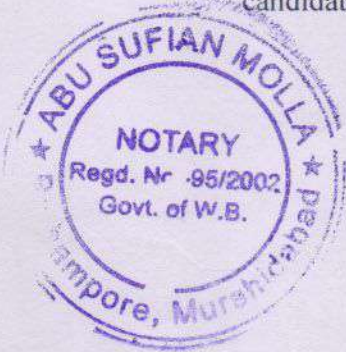

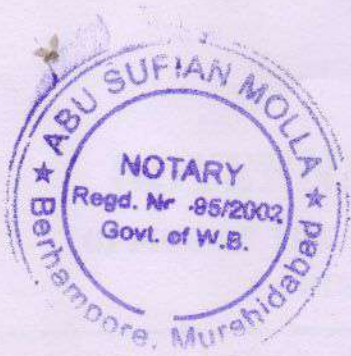

in the style of placing suitable type fire extinguisher CO2 4.5 kg. X 4, D C P .5kg X9 water CO2 9ltrs X6, Fire bucket etc. In all floor in visible location of the building shall be installed in accordance with I.S 2190-1992.

8) **General recommendation** : All the extinguisher should be tested at least once in a year by an authorise agency and certificate shall be pasted on the body of the extinguisher.

9) Fire licence shall have obtained in case of storing and processing with L.P.G. & other highly combustible article if any.

10) No cooking arrangement should be made in the college building.

11) Electrical main meter & main switch should be kept safe distance from the main building with proper protection by CO2 / DCP fire extinguisher.

12) Exit & Entry must be marked with red lamp.


13) Mock exercise and evacuation drill must performed with regular interval.

14) Good house keeping must be maintained.


15) All the teachers and non-teaching staff should have knowledge to operate fire fighting equipments and awareness of fire.

16) After completion of the all fire safety installation of the building a letter of intimation must be submitted to this office for final inspection to issue the final N.O.C. of the building.

17) Violation of any recommendation mention above legal action will be taken as per fire service Act. 1950 (upto date amendment) and the provisional N.O.C. shall be treated as cancel.

- 5) Arrangement shall have to be made for sealing all the vertical ducts by Parapet should materials of adequate Fire resistance capacity.
- 6) Parapet should be made minimum 2'6".

B. OPEN SPACE & APPROACH ROAD:

- 1) The open space of the surrounding building shall confirm the relevant building rules as well as to permit the accessibility and maneuverability of Fire Appliances with turning facility.
- 2) The approach road shall be sufficiently strong to withstand the load of fire engine weighing to 20 mtr.

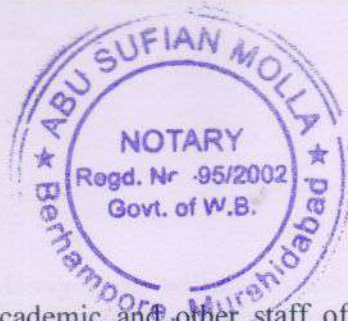

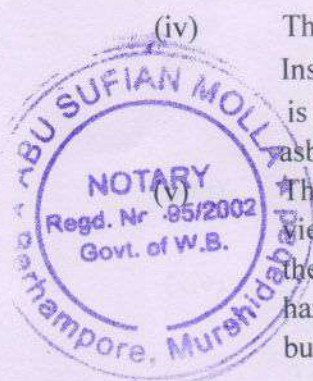

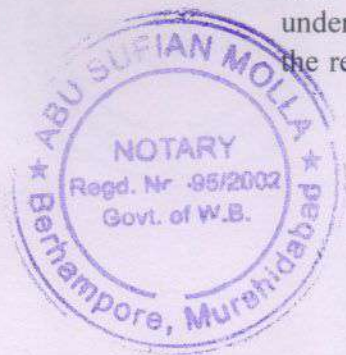
